

## **Release of Liability - Waiver of Legal Rights and Assumption of Risk**

In consideration for the participation to the "KITEIVAL" 2010 event and engaging in the sport of kiteboarding, and related kiteboard competition, I hereby understand and agree to this release of liability, waiver of legal rights, and assumption of risk, and to the terms hereof as follows:

1. I acknowledge that kiteboarding and the related competition therein is an action sport and recreational activity involving travel in three dimensions and such activity is subject to mishap and even severe injury to participating in the sport of kiteboarding and related competition.

2. I hereby RELEASE AND DISCHARGE the Organizing Committee of Kiteival Mauritius 2010, Sindbad Ltd, Naiade resorts, their officers, directors, elected officials, agents, employees, assigns, owners of equipment and the land used for kiteboarding and related competition activities (hereinafter collectively referred to as "Released Parties"), from any and all liability, claims, demands, or causes of action that I may hereafter have for injuries, disability, or death, or damages arising out of my participation in kiteboarding and related competition activities, including, but not limited to, losses CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES.

3. I understand and acknowledge that kiteboarding and related competition activities have inherent dangers that no amount of care, caution, instruction, or expertise can totally eliminate. I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING IN KITEBOARDING AND RELATED COMPETITION ACTIVITIES WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES.

4. I further agree that I WILL NOT SUE OR MAKE A CLAIM against the Released Parties for damages or other losses sustained as a result of my participation in kiteboarding activities and related competition.

5. I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgments, and costs, including attorneys' fees, incurred in connection with any action brought as a result of my participation in kiteboarding and related competition activities.

6. I will take full responsibility for, and hold harmless Released Parties for any injury that I may suffer or inflict upon others or their property as a result of my engaging in kiteboarding activities and related competition.

7. I agree that I will operate any kiteboarding equipment in a reasonable and safe manner so as not to endanger the lives of persons or property of any individual.

8. I have read and understand the above and acknowledge that the same constitutes a release of liability and a waiver of my legal rights and also acknowledgment of the assumption by me of all risks arising out of my engaging in kiteboarding activities and related competition.

9. I further represent that this release of liability, waiver of legal rights and assumption of risk shall continue in full force and effect for so long as I engage in kiteboarding activities and related competition which are in any way connected to or with the Released Parties.

10. I further represent that I am at least 18 years of age or that as the parent or legal guardian I waive and release any and all legal rights that may accrue to me or to my minor child as the result of any injury that my son or daughter (minor) may suffer while engaging in kiteboarding activities and related competition.

11. I hereby expressly recognize that this Release of Liability, Waiver of Legal Rights and Assumption of Risk is a contract pursuant to which I have released any and all claims against the Released Parties resulting from my participation in kiteboarding activities and related competition including any claims by the negligence of the Released Parties.

I HAVE READ THIS RELEASE OF LIABILITY, WAIVER OF LEGAL RIGHTS, AND ASSUMPTION OF RISK, FULLY UNDERSTAND ITS CONTENTS AND SIGN IT OF MY OWN FREE WILL.
